Notice of Default

Regarding: CHARGE – SHEET AND SUMMONS 31/01/2024

Within the universal maxim of law 'notice to agent is notice to principal and notice to principal is notice to agent'. All addressed parties jointly and severally as well as their successors, nominees, agents, and assigns.

Following my Notice of Conditional Acceptance, sent by Registered Mail RPP44 63900 05100 26712 81601, 2024, to the addressed, Shane Patton, agent of "VICTORIA POLICE ABN: 63 446481493", Trading as VICTORIA POLICE' (the business), you have failed to provide evidence, Quo Warranto, that any of those entities:

- has Commonwealth jurisdiction, powers of authority to impose a requirement, or determine an offence or penalty, upon a Subject of the Commonwealth standing as an unincorporated private entity (not the legal fiction, the "person"),
- is a Commonwealth Government entity pursuant to the Commonwealth of Australia Constitution 1900, as amended by lawful referenda ("Constitution")⁵,
- can provide evidence that the employees and agents of the business are Commissioned officers of the Crown², with lawful authority to enact or enforce laws, statutory regulations, directions, fees, penalties or charges, being their Oath pursuant to the Constitution, pledge including "I do swear that I will be faithful and bear true allegiance to Her Majesty Queen Victoria, Her heirs and successors (King Charles III) according to law. So help me God!" (in the Queen or King's "name"),
- have established Subject Matter Jurisdiction, and have first-hand personal knowledge or Authority, to make any such determination, judgement or imposition of any penalty,
- the debtor, is a living spirit within the body of a man, and not a corporate entity, or other fictitious WORDMARK or TRADENAME¹,



- can produce the person of whom has harm. According to Black's Law Dictionary, harm means to damage, injure, or hurt, or an agent upon delivery of evidence showing they are a bona fide creditor and Government entity ("Government" entity pursuant to the Commonwealth of Australia Constitution) and have provided evidence Quo Warranto.
- can provide evidence that the 'Road Safety Act 1986', the 'Fines, Penalties and Infringement Notices Enforcement Act 1994' were created by a Parliament of the Commonwealth under the Crown⁵, showing evidence, copy of certified proclamation of Royal Commission of Assent, pursuant to the Constitution s58.

I hereby serve Notice that failure to provide evidence Quo Warranto has created a permanent and irrevocable estoppel by acquiescence, **forevermore barring** the businesses, or their agents, or other "government entities" including but not limited to "VICTORIA POLICE ABN: 63 446481493", Trading as VICTORIA POLICE', FINES VICTORIA/INFRINGEMENT MANAGEMENT AND ENFORCEMENT SERVICES ABN 32 790 228 959, or their agents, from bringing any and all claims, legal actions, orders, demands, lawsuits, costs, levies, penalties, damages, interests, liens and expenses whatsoever, against living man, Raymond John, born of the family Pavilach, or the sole corporate entities, the legal fiction, the 'person' referred to as 'Raymond John PAVILACH', 'RAYMOND JOHN PAVILACH', 'PAVILACH, Raymond John', 'Raymond John Pavilach' or any other "Government" created *ens legis*/Trust.

Furthermore:

- Any prior Contract/s or Obligations the business may have had, through acquiescence or deception, with the "person"² or the incorporated entities 'Raymond John PAVILACH', 'RAYMOND JOHN PAVILACH', 'PAVILACH, Raymond John', 'Raymond John Pavilach', are null and void.
