- I hereby serve Notice that failure to provide evidence Quo Warranto has created a permanent and irrevocable Estoppel by acquiescence, **forevermore barring** the business, or its agents, assigns, associates and affiliates, or other "government entities" including but not limited to 'VICTORIA POLICE' ABN: 63 446481493, Trading as 'VICTORIA POLICE', FINES VICTORIA/INFRINGEMENT MANAGEMENT AND ENFORCEMENT SERVICES ABN 32 790 228 959 or their agents, from bringing any and all claims, legal actions, orders, demands, lawsuits, costs, levies, penalties, damages, interests, liens and expenses whatsoever, against the living man, Raymond, born of the family Pavilach, or the sole corporate entities, the legal fiction, the "person" referred to as 'Raymond John PAVILACH, 'RAYMOND JOHN PAVILACH', 'PAVILACH, Raymond John', PAVILACH RJ, 'Raymond John Pavilach'.

I hereby declare that the law of Agent and Principal shall apply and that service upon one is service upon another.

Furthermore, your failure to provide Proof of Claim in the form of the requested specific items comprises the tacit procuration of the business VICTORIA POLICE, FINES VICTORIA/INFRINGEMENT MANAGEMENT AND ENFORCEMENT SERVICES and/or their agents:

- That a privately owned or operated automobile may be used to travel privately, for non-commercial use, without a requirement to be registered with any State or Territory.
- Please be aware that this is a lawful Notice, a lawful instrument.
