- I hereby serve Notice that failure to provide evidence Quo Warranto has created a permanent and irrevocable Estoppel by acquiescence, **forevermore barring** the business, or its agents, assigns, associates and affiliates, or other "government entities" including but not limited to 'VICTORIA POLICE' ABN: 63 446481493, Trading as 'VICTORIA POLICE', 'FINES VICTORIA'/'INFRINGEMENT MANAGEMENT AND ENFORCEMENT SERVICES', ABN 32 790 228 959 or their agents, from bringing any and all claims, legal actions, orders, demands, lawsuits, costs, levies, penalties, damages, interests, liens and expenses whatsoever, against the

- That 'registration plate number '1NM6UO' is null and void and Licence No. 044491127 is kept under duress (vi coactis, signed as so) and not required to travel in a private capacity.
- That a privately owned or operated automobile may be used to travel privately, for non-commercial use, without a requirement to be registered with any State or Territory.
- Please be aware that this is a lawful Notice, a lawful instrument.
