General Affidavit

The within named (Affiant), Raymond John of the family, Pavilach, who is a resident of Mildura, State of Victoria, Country Australia.

Raymond, Personally came and appeared before me, I the undersigned Notary Public, and makes this his Statement, testimony and General Affidavit under oath or affirmation, in good faith, and under penalty of perjury, of sincere belief and personal knowledge that the following matters, facts and things set forth are true and correct, to the best of his knowledge.

On the afternoon of the 31st of January 2024, at approximately 4pm I was stopped in my private trust conveyance. At the time, as I was not under arrest or under any obligation to stop for State officers, I did so as a matter of respect for the uniform, lights and sirens, on Thirteenth Street and again in the interest of road safety on Walnut Avenue in Mildura, by Mildura Police, detained, breath tested, then arrested and hand cuffed on the side of the road and roughly handled into the back of the Victoria Police wagon vehicle.

I am an elderly 84 year old man who wears hearing aids, and could not clearly hear everything of what was being said. I have developed the ability over time to read "body language" and it was extremely apparent from both Constable's body language and demeanour, that their intention was to intimidate, threaten and coerce me. I did immediately feel intimidated and physically threatened by the two young robust male officers with their lethal weapons and tasers attached to their huge arms and legs. Under severe duress I complied with demands to complete a breath test when I was first stopped and, to get out of the vehicle where they opened the bonnet of the car to apparently obtain the VIN number of my private conveyance.

I repeatedly told them that I had done nothing wrong, and my private conveyance is private Trust property and that I have use of it. I gave my documentation of CLAIM OF RIGHT (which was delivered to Mildura Police Station back in June 2023) to Constable Jared Jensen and without doing his due diligence by reading it, he threw it back in my window after quickly browsing over the first few lines stating, "that's gobble de gook, it means nothing". He was rude, obnoxious, demanding and demeaning in his attitude toward me the entire time, and even said, "WE ARE THE POLICE, WE CAN DO ANYTHING WE LIKE".

In Thirteenth Street, Constable Jared Jensen after breath testing me, said something unclear, about me staying with my motor vehicle and after returning from his vehicle forcibly and acted like a child by throwing some paper through my partially opened window effectively littering on my private trust property. I politely told constable Jared Jensen and E Bogeman that I was not accepting their paperwork and I did not know why he did not listen to me or accept my paperwork as my proof. I have done my due diligence by kindly notifying principal and agents of my Non-Corporate standing and allegiance to the Crown and it remains unrebutted.

I reiterated that I was not accepting any corporation paperwork and gave it back outside the window to Jared Jensen, with which Jared Jensen let the paper fall to the ground. Ridiculously and again childlike, Jared Jensen mumbled something about littering and returned to his police vehicle. I was simply returning unsolicited, unwanted, and unnecessary paper that did not belong to me the living man, the fault that it fell to the ground was the fault of Jared Jensen himself.

At this stage I considered the matter closed and as the officers had left me in my private trust conveyance and returned to their vehicle, I proceeded off slowly to drive home.

Suddenly I observed officers Jared Jensen and E Bogeman, with lights and sirens blaring, come dangerously speeding up behind me again in their vehicle. Other confused road users were in between me and them and all around the roundabout on Thirteenth Street and Walnut Avenue. Constable Jared Jensen nearly caused a collision by weaponizing his vehicle in his rush to pull me over again. His reckless behaviour could have easily caused grievous bodily harm or even death with another traveller in the confusion by forcing the operator of the conveyance off the road in Walnut Avenue.

When officer Jared Jensen came up to my private trust conveyance, he was very angry and threatening with a raised voice and said I was under arrest, but I know not on what charge or authority he was claiming as he was incoherent and actually none of the officers explained to my satisfaction the entire time of my detainment. I believe it was an attempt to intimidate and scare me since they were in breach of section 116 of the Commonwealth Constitution: 80.2 of the Criminal Code 1995 as the service they were trying to provide was unsolicited and not wanted.

Again, I told them that I had done nothing wrong under the Constitution 1900 imp. and my private conveyance is private Trust property and that I have use of it.

They proceeded to trespass on my private trust conveyance and remove me from my private trust conveyance, trespassing against my personal body and hand cuffed me and forced me to climb into the back of the police wagon. I had just been returning home from an appointment with my local GP Doctor because of a fall I had at home the previous Saturday and I was in a great deal of pain so being hand cuffed certainly inhibited my movement and increased my physical pain further. So much so that Constable E Bogeman had to put the seat belt on for me. There was very little duty of care shown.

At the Mildura Police station, I was ushered to a small, confined room with a backless concrete stool to uncomfortably perch on and a metal table; it was about the size of a toilet cubicle. I was held for nearly 4 hours and for the majority of the time had six (6) individuals literally standing over me in this small confined space. They were all very intimidating and used coercion and stand over tactics to attempt to force me into signing papers that did not pertain to me, the living man or feel the need to sign, as I had done nothing wrong under the 1900 imp. Australian Constitution. Article 61 of the Magna Carta 1215; states Practical Lawful Dissent: I am lawfully allowed to disobey all Acts and Statutes imposed by an illegal Government.

I felt belittled and ridiculed particularly by Jared Jensen with him physically laughing at me about not signing their paperwork that did not pertain to me as the living man. I made a point by saying to Sergeant Mick Globen about Constable Jared Jensen "he thinks all this is funny". There was no respect for my personal rights as a living man, elderly, in pain or not. I was threatened with being "thrown in jail, (incarceration overnight) fingerprinting, fines, court proceedings and magistrates court" if I didn't sign their paperwork.

I didn't sign any paperwork other than to release my personal effects that were taken away from me on arrival at the Mildura Police Station. I was released when my daughter came to collect me at approximately 7.52pm and again flanked and ushered outside by four of the individuals and met out the front of the Police Station by the other two Constables Jared Jensen, E Bogeman and my daughter Melanie.

Constable Jared Jensen again tried to coerce and force me to take paperwork from him, for which I again politely declined. Jared Jensen mumbled something about mailing them to me. I was very tired and in severe pain, so I was in desperate need to be taken home to rest.

I said, "am I free to go"? Jared Jensen answered "yes" (so I am a free man), and we left shortly thereafter Melanie collected their names. Melanie told me she had recorded (with the full knowledge of constable Jared Jensen as she had a recording visible device on a public footpath) him admitting and stating that there was no contract between us or myself and the Corporation which is VICTORIA POLICE.

My daughter and I have both had interactions with Mildura Detectives from December 2022 on a case about my neighbour across the road. Even though we were willing to help, and the incident had nothing to do with us, it resulted in three (3) detectives trespassing on our private trust home/land with an unlawful warrant because there was no Crown Seals on it, breaking and entering and committing larceny by removing and keeping to this date, the security camera hard drive. I believe this incident was an aggressive targeted attack out of malice, prejudice, and ignorance of the law, as The Victoria Police, Attorney General Jaclyn Symes, Vic Roads CEO Dean Tillotson, Chief Commissioner of Police Shane Patton, Minister for Police Anthony Carbines and Mildura Police Station all agents and principals were notified of my original Non-Corporate Commonwealth standing by way of the attached letter through Australia Post in June 2023.

Mildura Police Station also received a second copy on the 15th of January 2024 with the attached fee schedule. In both instances the required ASIC claim form 418 to contract with a corporation was not completed by any principal or agent or received by me in any way, shape, or form. It remains unrebutted, so therefore, no joinder exists so no contract exists.

Thus, the conditions within the attached notice and fee schedule to principal and agents was deemed settled, notified, and officially understood. The failure to notify all the principals and agents of my Non-Corporate standing and do their due diligence in their own private capacity and occupants of their offices has been the consequence of the above interaction. Ignorance of the law is no excuse.

My creator game me the right to travel freely in my Country of birth, so consequently Agents Jared Jensen and E Bogeman have committed a criminal offence of trespass, breached Trust Law and breached my constitutional and common law rights to peacefully travel on the King's roads unhindered and without menace. It is our intention to live and travel in peace without interference, harassment, or menace. We must be allowed to live on this land and travel in peace in the King's realm.
