- 3: I do not consent to you or any other agent or the principal of any NSW Government Department or separately registered corporation, including that of NSW POLICE FORCE exercising any right of ownership over my flesh and blood, and or personal possessions and property including but not limited to:

Unlawful detainment, apprehension or arrest, assault – whether 'justified' or otherwise, unlawful and or illegal demands for personal or other details and or information, using the threat of harm, intimidation, verbal assault, any and all damage to property, and or persons, the use of invasive tactics whether verbal, physical or otherwise, any other act deemed by myself to be contrary to my right to the peaceful occupation of my personal space, anything that is in breach of my legislated and other legally enshrined rights, inflicting political agenda which conflict with my own, onto my person, or other interference with my right to political liberty, reading, digesting, comprehension of unsolicited mail, composition and creation of response to unsolicited mail, including any and all associated costs, AND anything deemed by myself to be contrary to my naturally inalienable rights as a living, sentient being.

- 4: Any action by any party which breaches any or all of the Items listed at point 3 above and engages with us, has, by so engaging, incurred Engagement Charges and be liable to the extent of the Fees listed in the attached Fee Schedule. That Fee Schedule is attached hereto and identified by the heading "Engagement Charges Fee Schedule". DJM00101061952

The following are the Fees due and payable for per hour and/or per incident/event engagements. These Fees are separate and inalienable, and cumulative, and will accrue interest at the rate of 10% per month. This Schedule is exclusive of any and all costs associated with proceedings that arise from the act of engagement. These fees are calculated in AUSTRALIAN DOLLARS however debts will be required to be paid in ounces of Silver, from 30th September, 2022, and while current, at the time of Notification, these fees are subject to increase without warning or additional notification.

All Fees liable in accord with this Schedule are payable at fourteen-day intervals and are able to be pursued to collection by us, via legal and lawful channels including but not limited to collection agencies, private debt collectors and or others assigned by us to do so.

Following my Notice of Conditional Acceptance, sent by Registered Mail 44 63900051003274280602, 2024, delivered 29th October 4.52am and Notice of Default sent by Registered Mail RPP4463900051002585860602, 2024 delivered 4th November 04.49am, to the addressed, Greg Wells, Chief Executive Officer, agent of "SERVICES NEW SOUTH WALES, ABN: 37 552837401", (the business), you have failed to provide evidence, Quo Warranto.

- I hereby serve Notice that failure to provide evidence Quo Warranto has created a permanent and irrevocable Estoppel by acquiescence, **forevermore barring** the business, or its agents, assigns, associates and affiliates, or other "government entities" including but not limited to NEW SOUTH WALES POLICE ABN: 43 408613180, Trading as 'NEW SOUTH WALES POLICE and SERVICE NSW' ABN: 37 552837401 , trading as "SERVICE NSW" or their agents, from bringing any and all claims, legal actions, orders, demands, lawsuits, costs, levies, penalties, damages, interests, liens and expenses whatsoever, against the living man, David, born of the family McCorkell, or the sole corporate entities, the legal fiction, the "person" referred to as 'David John McCorkell', 'DAVID JOHN, MCCORKELL', 'MCCORKELL, David John', 'MCCORKELL DJ', 'David John McCorkell'.

I hereby declare that the law of Agent and Principal shall apply and that service upon one is service upon another.



Furthermore, your failure to provide Proof of Claim in the form of the requested specific items comprises the tacit procurement of the business NEW SOUTH WALES POLICE, SERVICE NSW and/or their agents:
